On this day the Glandorf Village Council and Board of Public Affairs met in regular session. Calling the meeting to order at 7:30 pm with the Pledge of Allegiance was Mayor Charlie Schroeder with the following members present: Brian Inkrott, Dale Warnecke, Zachary Klausing, Scott Buckland, Kristen Gerding-Heffner and Douglas Trombley. Board of Public Affairs members present were: Chris Recker, Brian Seimet and Derrick Schierloh.

Minutes from the July 5, 2023 regular council meeting was read by Fiscal Officer Sharon Stechschulte. Motion approving the minutes as read was made by Buckland and seconded by Warnecke. All members were in favor.

Minutes from the July 25, 2023 special council meeting was read by Fiscal Officer Sharon Stechschulte. Motion approving the minutes as read was made by Klausing and seconded by Gerding-Heffner. All members were in favor.

Bills were presented by Fiscal Officer Sharon Stechschulte. Motion approving the bills was made by Warnecke and seconded by Buckland. All members were in favor.

Cody Michaud & Jeremy Ringger from Weigand Construction introduced themselves. Weigand Construction is based out of Ft. Wayne, Indiana. They were looking for more market penetration in Ohio and feel that the Village of Glandorf and surrounding communities align with Weigand's goals and work force ethics. A motion was made to sign the purchase agreement by Trombley and seconded by Gerding-Heffner. All members were in favor.

Resolution #2216 was presented to council by Mayor Charlie Schroeder to adopt the Village Comprehensive Community Plan prepared by Reveille. A motion to adopt the plan was made by Inkrott, seconded by Gerding-Heffner. Roll being called, vote was as follows:

Members from the Glandorf Lions Club presented an update on the proposed canoe/kayak launch on the 22 Acres currently owned by Nancy Warnimont (adjacent to Ted & Kelly Ellerbrock's home on E. Blake St.). The grant application is due August 11, 2023 and is close to completion. They did have a neighbor wanting to keep the sledding hill in the area. The Lions Club confirmed that the launch area will not affect the sledding hill. The Glandorf Lions Club requested permission to have information available at the ParkFest on the potential project. Council agreed that this should be ok.

Village resident Andy Gray questioned the Glandorf Lions Club representatives if they needed flood plain permits. Representatives were unsure but will look into that. He also questioned if there will be hours posted, gates and how the area will be kept clean. Rosemary Buerger stated that there will be operating hours and an

Mayor Schroeder requested that the zoning change request from Ellerbrock Enterprises LLC of parcel 31-589010.0000 from R-1 to B-1 which was tabled last month be revisited. This parcel includes 12.444 acres on the north side of US 224 across from Brooky's. Council agreed that this should be put on the next planning commission meeting agenda for review again. The next planning commission meeting is scheduled for August 26, 2023.

Mayor Schroeder presented a proposal from Reveille to update the current zoning ordinance (#1323) approved May 6, 1997 for an amount not to exceed \$21,500. A motion was made to proceed was made by Buckland and seconded by Warnecke. All members were in favor.

Bockrath & Associates is requesting permission to post the sealed bid information for the main street stormwater drainage improvement project. All bids are due by August 31, 2023 at 9:00 in the Village Office. Brian will discuss the status of this project and timeline with Bockrath & Associates.

On July 25, 2023, Ohio Municipal League (OML) field representative Mike Barhorst meet with Charlie, Sharon & Joyce to discuss the Local Government Funding issues and discuss the village's fiscal needs and various grants available to fund potential projects. He encouraged the Village to contact local state representatives on a rotating basis to restore the local government fund which has decreased over the last few years. The OML believes that restoring the fund will allow the village to manage and spend the funds on the village's needs decreasing the state involvement thru grants, loans, etc.

A finance meeting was schedule for August 15th at 7:00 pm. David Conley, President of Rockmill Financial Consulting will be there to present their service options for financial budgeting, planning and levy options.

Chris reported that the village did not receive the \$61,000 Ohio Dept of Development (ODD) grant to help fund the manhole repairs and help fund the villages preventive maintenance program currently in place. The village was awarded a \$45,000 grant to purchase a new 6" Trash Pump to replace the 4" Trash pump, however, due to an error on the grant application, he needed to contact them to see if we still are able to receive the grant money.

Mark noted that there is power for the mixing system to be installed by Leary Construction Company. We will need Kahle Electric to put a box over the power box for safety and security reasons.

Police Chief Jared West stated he did purchase the rifle, ammo and other accessories council approved at the last council meeting. He stated that the BCI returned the computer they had for review. Relentless will clear off this computer and then it will go to Mark.

Andy Gray reminded all present that the Glandorf Fire Department's Golf Cart Poker Run will be on August 19, 2023. Red Feather will be playing after the poker run in Deters Park. All proceeds will go to the Putnam County CAPS program.

Andy also questioned the process the village has for council meetings and informing village residents of proposed items. Mayor Schroeder explained to Andy that all meetings are open to the public. It is the intention of the village to update the website and put as much information on that in the future. The village also uses FaceBook and the Daktronics system to inform residents of things going on.

Rosemary Buerger from the Lions Club said they are still working on a date for the family movie night.

Whit Linahres has a meeting scheduled with Ron Black to discuss the best place for the Glandorf Germany sign near the park entrance.

The Putnam County Board of Commissioners will be conducting a public meeting on Tuesday, September 5, 2023 at 11:00 am in the Courthouse Assembly Room declaring portions of the unincorporated areas of Putnam County, Ohio to be restricted, prohibiting construction of economically significant wind farms, large wind farms and large solar facilities pursuant to ORC 303.57. They are requesting that the village share this information with village residents. This will be put on FaceBook and the Daktronics system.

Zach Klausing received complaints about the Liberty Drive lights blinking. Mark is aware of the issue. Sarka Electric put a new "eye" on but appears to still be happening.

Joyce Fuerst will be administering the village Facebook account which Kristen started a year ago.

The next council meeting is scheduled for Tuesday, September 5th at 7:30 pm.
