ORDINANCE NO. 1498

AN ORDINANCE REGULATING PEDDLERS AND SOLICITORS AND REQUIRING A PERMIT IN THE VILLAGE OF GLANDORF, OHIO

WHEREAS, Council desires to and believes it is in the best interest of the residents to regulate peddlers and solicitors within the Village limits of Glandorf, Ohio; and

WHEREAS, Council desires to require a permit for peddling and soliciting within the Village.

NOW THEREFORE, BE IT ORDAINED BY THE VILLAGE COUNCIL OF GLANDORF, PUTNAM COUNTY, OHIO, THAT:

Section I: No person, salesman, firm or corporation shall sell, barter, bargain to sell or solicit orders for goods, wares, or merchandise by retail for immediate or future delivery from place to place or from house to house within the Village of Glandorf, Ohio, unless such person has first been issued, at least ten (10) days in advance, a permit to do so as provided by this Ordinance.

Section II: No person shall obtain or seek to obtain funds for any cause whatsoever by means of canvassing from place to place or from house to house, unless such person has first been issued, at least ten (10) days in advance, a permit to do so as provided by this Ordinance.

Section III: Exceptions:
(a) Nothing in this Ordinance shall be construed to make it unlawful for the owner of any product of his own raising, production or manufacturing to sell, bargain to sell or solicit orders by himself or to advertise such articles or products in the Village without the permit required by this Ordinance.
(b) This Ordinance shall not apply to any person acting solely on behalf of a nonprofit organization or for a charitable purpose, to any person engaged in the sale and delivery of milk, dairy products or other food products or to newspaper carriers along their regular delivery routes.

Section IV: Applications for permits must be filed with the Village Administration during regular office hours on a form furnished by the Village and shall be accompanied by credentials and other evidence of good moral character and identity of the applicant and contain at least the following information:
(a) The name and address of applicant;
(b) The name and address of the person, firm or corporation by whom the applicant is employed;
(c) The length of service of such applicant with such employer;
(d) The place of residence and nature of employment of applicant during preceding year;
(e) The nature and character of goods, wares, or merchandise to be offered by applicant;
(f) A personal description of applicant;
(g) A description of any vehicle to be used, license plate number, and date and number of operator's permit; and
(h) Applicant may be required to submit to fingerprinting for identification and investigatory purposes.

Section V. The fee for the permit required by the Village shall be \$15.00 for a one-day permit; \$50.00 for a one week permit and \$150.00 for a one-month permit, payable by cash or bank issued check only at the time of application.


- Section VI.** The permit issued pursuant to this Ordinance shall be carried with the applicant at all times while using it and shall be exhibited to any person inquiring.
- Section VII.** All business conducted under authority of the permit issued pursuant to this Ordinance shall be conducted between the hours of 9:00am and sunset.
- Section VIII.** No permit issued pursuant to the provisions of this Ordinance shall be assignable or transferable. No permit shall authorize any other person other than the one named in the permit to do business. No permit holder shall conduct any other business requiring a permit than that which is named in the permit.
- Section IX.** The Chief of Police is hereby authorized to revoke any permit issued pursuant to this Ordinance upon good and sufficient cause.
- Section X.** No permit holder under this Ordinance shall remain, sell, barter, bargain to sell or solicit at a property against the wish or desire of the owner or tenant.
- Section XI.** Whoever violates any of the provisions of this Ordinance shall be guilty of a minor misdemeanor.
- Section XII.** This Ordinance shall take effect on the earliest date allowed by law.


That it is found and determined that all formal actions of this Council of the Village of Glandorf, Ohio, concerning or relating to the passage of this Ordinance was passed in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that result in such formal action, were in meetings open to the public, in compliance with all legal requirements including Section 121.22 of the Ohio Revised Code.
