ORDINANCE NO. 1496

AN ORDINANCE ESTABLISHING A \$5.00 MONTHLY STORM WATER USER CHARGE AND ESTABLISHING A STORM WATER FUND FOR THE VILLAGE OF GLANDORF, OHIO

Whereas, the Village of Glandorf finds it necessary to establish a fee for storm water services in the form of a storm water user charge to users within the corporation limits of Glandorf, Ohio; and

Whereas, the establishment of a storm water user charge is necessary to maintain the integrity of the current storm water system and to provide for future improvements and mandates, and

Whereas, all funds generated by the \$5.00 monthly storm water user charge are to be charged per meter and shall be billed and paid along with the current utility bill; and

Whereas, the storm water user charge must be kept in a separate account known as the Storm Water Fund that can only be used for capital improvements, repair and maintenance associated with storm water infrastructure improvements; and

Whereas, the Village of Glandorf desires to obtain formal approval from the State Auditor's Office for the establishment of a fund for Fiscal Year 2020, and thereafter for the Storm Water Fund.

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF GLANDORF, PUTNAM COUNTY, OHIO, TWO-THIRDS OF ALL MEMBERS ELECTED THERETO CONCURRING:

Section 1. That a \$5.00 monthly storm water user charge is established and is to be applied per meter to any user that affects the Village of Glandorf storm water system. Determination of user is based on property ownership and is to be ultimately determined by Council.

Section 2. That all users are to be billed and the storm water user charge collected along with the current utility bill.

Section 3. That all funds generated by the \$5.00 monthly storm water user charge must be kept in a separate account that can only be used for capital improvements, repair and maintenance associated with storm water infrastructure improvements and further that the appropriate Village Employees are authorized to take all actions necessary to establish said Storm Water Fund.

Section 4. That formal approval by the State Auditor's Office is hereby requested for the establishment of a fund for Fiscal Year 2020 and thereafter for the Storm Water Fund.

Section 5. That the Fiscal Officer is hereby authorized to take any and all actions necessary for the establishment of the Village of Glandorf Storm Water Fund.

Section 6. That the Fiscal Officer be and hereby is authorized and directed to cause publication of this Ordinance to be made in a manner as provided for according to law.

Section 7. This Ordinance is effective at the earliest time allowable under the law.
